イ. 納入金額が、納入書等の「納入金額(1)」欄の税額と異なる場合（退職所得にかかる税額を併せて納入する場合）

納入書等の「納入金額(1)」欄を必ず2本線で抹消し、「納入金額(2)」欄の「給与分」欄に給与所得にかかる納入金額を、「納入金額(2)」欄の「退職所得分」欄に退職所得にかかる納入金額を、また、それらの合計額を「納入金額(2)」欄の「合計額」欄に記入してください。

なお、退職所得にかかる税額のみを納入する場合は、納入すべき税額が印字されていない納入書（後ろの2枚）を使用してください。（記入例(3)を参照してください。）
